

5th Judicial District Drug Court
Adult Intensive Supervised Probation
RANGE OF SANCTIONS

Sanctions are penalties that may be levied against you by the Drug Court Judge as a response to violations of your terms and conditions of probation. Sanctions may be imposed individually or in any combination. They are listed in order with the most severe sanctions listed first.

Court Imposed Sanctions

1. REMOVAL FROM PROGRAM: Drug Court Judges after consultation with treatment team. Case is then referred to another District Judge for Revocation Hearing. You have a right to have an attorney present during Drug Court sessions, however, this is a treatment program and sanctions may be applied by Drug Court Judge.
2. HOUSE ARREST - You may be restricted to your home up to 24 hours a day. During such times you may not leave your residence except for work, Court ordered activities, or other reasons defined by the Court. House Arrest may or may not include an electronic monitoring device (EMD). Use of EMD's will result in a daily cost to cover the fees of this service.
3. EXTENSION OF PROBATION/PAROLE PERIOD - Failure to complete conditions within the prescribed time period may result in a longer period of probation. Justification must be presented indicating such failure was beyond the reasonable control of the client. This may be done by Court Order or Voluntary Extension to allow completion of financial obligations or imposition of other internal sanctions.
4. JAIL - You may be held in the local jail for up to 60 days per violation, as a condition of your probation. You will receive no credit for jail sanction time served.
5. DRUG COURT – Your attendance in Drug Court sessions may be increased for program violations.
6. ALCOHOL/DRUG TREATMENT - You may be assigned more treatment sessions for program violations including but not limited to positive urinalysis test.
7. COUNSELING - You may be assigned to participate in some form of group or individual counseling to address emotional issues, mental health concerns, anger control issues, financial/credit needs, etc. "Successful completion" will be determined by the program you attend and will include following any recommendations of discharge from such program.

Other Sanctions (Internal)

8. LEVEL MOVEMENT - Placement in a more restrictive level of community corrections or heightened reporting requirements could result from specific program violations, chronic unemployment, legal violations, or other crisis situations.
9. DAILY ITINERARIES - Clients may be required to provide a daily accounting of your whereabouts, subject to periodic verification. Itineraries may be required daily or on weekends for a specific period of time.

10. COMMUNITY SERVICE HOURS - Additional hours may be assigned as a consequence for specific violations.
11. WRITTEN OR VERBAL WARNING – The Judge may choose to give a simple warning for minor violations. This may be done verbally or in writing.

MAJOR PROGRAM VIOLATIONS: Samples include but are not limited to the following:

1. Not attending Drug Court sessions.
2. Not reporting to your assigned officer as requested for a period of 10 days and/or leaving the county without permission and not returning.
3. Conviction of any new felony charge or DUI during the course of your assigned supervision.
4. A misdemeanor conviction in combination with other technical violations may be sufficient to warrant a revocation.
5. Continuing in a pattern of illegal drug and/or alcohol usage even after being afforded the opportunity for treatment.
6. Having a pattern of intentional conduct that demonstrates a refusal to comply with or participate in the treatment process.

GRIEVANCE PROCESS:

Should I disagree with any actions made by the assigned officer in the supervision of my case, I understand the following steps should occur:

1. I will advise my assigned officer of the disagreement and attempt to resolve the issue.
2. If I cannot reach a settlement with my assigned officer, my complaints must be submitted in writing. The Director will initiate the scheduling of appointments after reviewing the written documentation on the case.

I have been provided a list of alternative sanctions and major program violations, and the process for handling grievance.
